I. Call to order

V. Executive Committee Slate

VIII. Race to the Top Grant

Cindy Weigel presented about the Race to the Top Grant. The purpose of the grant is to promote high quality programs, comprehensive assessment, competent workforce, and comprehensive data systems to promote an end result of healthy and successful children.

The grant is due October 14. Need letters of support for this system. Tom Rendon will be sending out letters for request.

 - a. What do individuals do with info from meetings?
8. Promoting/Outreach for Early ACCESS (13 votes)
 - a. Coordinated Intake
 - b. Use of technology for P.R.
9. A.C.E/Trauma Informed Care/Family Mental Health (15 votes)
 - a. Experiences/How can we use that data to inform EA?

X. OSEP Leadership Conference Update

Council members who participated in the meeting in D.C. spoke about their experiences while attending the meeting. Cindy Weigel, LauraBelle Sherman-Proehl, Maria Cashman, Heather Moorman, and Kasey Vermillion attended the conference.

XI. Part C Update:

Memorandum of Agreement- sign across the agencies for the next 5 years. Have to develop action plan of what that looks like for the next 5 years. Critical to take some of the topics and make part of the action plan.

XII. Annual Performance Report/State Improvement Plan Indicator

More information will be provided in November. As a state, we will look at data and decide what we want to focus on to create a plan of action to determine what our indicator is going to focus on. OSEP (national office) is going to offer guidance on what the new indicator will be. Other states have focused on child find, family outcome indicator (for example). This is a 3 year process (starting in 2015).

XIII. Committee Reports

Parent

Stacy and Kasey are co-chairs and have ideas for day on the hill. Get personal stories and how to display them in case they can't go to day on the hill. Jude's story was a good example of how to put a video together. Meghan suggested that we could try to reach out to our legislators and show them the video one on one or via email when they are not in session so they are not bombarded.

Public Policy

Some of the ideas are the autism language that was passed- insurance mandate. Any policies around First 5.

Governor's Report

Aryn Kruse is chair. They Brainstormed how we can display information to be more attention grabbing and concise. They talked about using parents as presenters to include stories in the report. Try to take a systems focus and how working across agencies to improve children.

Membership/Nominations

Gladys is the chair of the committee. We looked who will be eligible or ending terms for the current year. We would like to have more males and diversity in the council. We need to look for statewide representation. Paula reported the Early ACCESS is the topic of the November ASK meeting.

By-Laws

XIV. Sharing of Activities and Upcoming Events

Paula reported that Saturday May 3 was the "Together We Can" conference. Will pay parents mileage, etc. and childcare is available for reimbursement. Had 300 parents attend this year. The goal for this year is to have 500 parents register for this conference.

Stacy reported that they do a fundraiser for Prader-Willi syndrome. They raised over \$12,000 this year.

Gretchen reported that the ACE summit October 14- we will be releasing data and look at how we start at different communities and how to build awareness at community level.

LauraBelle reported that we have a new Director of Education (Brad Buck).

Early Childhood Fall Institute is next weekend in Altoona. Aryn Kruse is taking 5 students to present on embedding math and science in home intervention (birth to three).

Angie Hance doing professional development on RBI (Routines Based Interviews/Intervention) with AEA (Area Education Agency) staff. Adjournment

Meghan is on the governor's disability council. This year they are focusing on employment. Discussion goes to the IEP and then the birth (IFSP) about why we aren't asking parents early on what the goals of their children are and what they want to do for employment. Parents reported that they should start asking that question early on.

Distance Mentoring Model of Professional Development is having a big meeting in September (also update in the DE). First EALG (Early ACCESS Leadership Group) meeting is Oct 9 and 10.

Heather Moorman adjourned the meeting at **3:02 pm**.
