Iowa law requires that individuals cited for operating a motor vehicle while under the influence of alcohol or drugs complete a drinking driver education course and a substance abuse evaluation. In order for the State of Iowa to release the hold placed on your driving record, you will need to submit proof that you have completed the education and evaluation. **This form should be submitted with documentation that shows a drinking driver education program and/or a substance abuse evaluation/treatment were completed outside of the State of Iowa.**

Complete this form and return it with all documentation noted below. There is an administrative fee of \$25 for submitting documentation for drinking driver classes completed out of state. Payment in the form of a cashier's check or money order should be made out to the Iowa Department of Education. You may also pay this fee with a credit/debit card at: <https://epay.educateiowa.gov> **We are unable to accept personal checks.**

OWI REQUIREMENTS

You will need to submit a certificate or letter of completion from the education program which clearly specifies the name of the agency providing the education and its location, the number of hours of the course, and the date the course was completed. The course **MUST** be a state approved program and at least 8 hours in length. **Treatment will not be accepted in lieu of education.** Please note that on-line classes will not be accepted.

You will also need to provide documentation of a substance abuse evaluation/assessment which clearly specifies the date of the evaluation, the name of the evaluator/agency, the evaluator's recommendation, the evaluator/agency's location/telephone number. If the evaluation recommends treatment, documentation showing when and where the treatment was completed must also be submitted.
